

Prevent Training Audit for schools April 2016

The Counter-Terrorism and Security Act 2015 places a LEGAL DUTY on specified authorities, including schools, to prevent people from being drawn into radicalisation, terrorism, and violent extremism. One specific action is to train staff to recognise, and respond to, related concerns. Headteachers are free to choose which training package they use but ALL staff are expected to receive training.

The level of training I recommend is the Home Office Workshop to Raise Awareness of Prevent (WRAP) for at least the core team of SLT, SEN, and the school and Governor Leads for Safeguarding Lead and Prevent.

Please complete this brief audit, retain a copy for your Ofsted Safeguarding file and return a copy to jade.gutteridge@peterborough.gov.uk by **Tuesday 2nd May** in order that the outcomes can be collated to evidence compliance for Ofsted and Local Authority. It will also enable us to develop a current contact list of all SPOCs for Prevent.
